

I look forward to meeting you and your families frequently this month as we celebrate this beautiful Christmas season and joyfully usher in the New Year together.








CHRISTMAS BAZAAR - STALL BOOKINGS & TICKET SALES FOR DECEMBER EVENTS

1. Stall bookings -

- a. Registrations commence at 9:00 AM, Wednesday, 3rd December in the Reception, and stall allocation at 11:00 AM, in the Ball Room.
- b.Only One stall per member will be allowed on a first-cum-first serve basis, to MEMBERS ONLY.
- c. Stall allocation will happen through a draw of lots, and at 11:00 AM on the same day. The allotted member must be present.
- d. Members booking stalls for guests must use BONA FIDE stalls only. Violations will result in action, including potential complaints against the member.

2. Ticket and Table Sales for all events -

- a. Opens on Thursday, 4th December, 2025 at 5:00 PM
- b. Ticket sale counters will be placed near the Reception from Friday, 5th December to Thursday, 18th December, 2025. Counter timings: 10:00 AM to 2:00 PM and 5:00 PM to 9:00 PM daily.
- c. Tickets can be purchased using the Member's Smart Card only.
- d. Members can also book tickets & tables online via the CC Mobile App from 4th December, 5:00 PM onwards.
- e. Table reservations will be available for the following December events Carols by Candle Light, Cake & Wine, Yuletide Ball and New Year at Rs.200/- per table. Maximum 2 tables per membership.
- f. Tables will be sold only against a purchased member ticket for the event.
- 3. <u>Dress code:</u> For Cake & Wine (24th December) and Yuletide Ball (27th December) Strictly formal. Gentlemen: Nehru Jacket, Formal Suit, or Odd Coat with tie/bow tie (compulsory). Ladies: Evening attire. Jeans, chinos, casual trousers, sports shoes, and sneakers are not permitted.
- 4. All Club dues must be cleared to be eligible to buy tickets.
- 5 Members unable to purchase in person may send their Smart Card with an authorization letter to the Secretary, mentioning the full names of the guests and their respective ages, accompanied by relevant ID proof for all the guests.
 - a. The authorised representative must have photo ID.
 - b. Secretary may validate and approve, or reject if in doubt.
 - c. Bookings with authorization letters will be accepted from Friday, 5th December, 2025.
- 6.Occasional Member tickets issued only through members. Maximum 6 guests over 12 years per event (except Cake & Wine and New Year's Eve: maximum 4 guests).
- 7. Refer to "Announcements" for full details.
- 8. Valid ID proof (Aadhaar Card) will be required at the entry, for all guests attending the event/s.
